

Consensus Standards Approval Committee Voting Results and Decisions for the Fall 2022 Measures

The Consensus Standards Approval Committee (CSAC) convened for a web meeting on July 24, 2023, to review candidate measures for the Fall 2022 cycle. The tables below illustrate voting results for the following endorsement & maintenance (E&M) standing committees:

- All-Cause Admissions and Readmissions
- Cardiovascular
- Geriatrics and Palliative Care
- Patient Experience and Function
- Patient Safety
- Prevention and Population Health
- Renal

For the Fall 2022 cycle, the CSAC endorsed 19 of the 28 measures reviewed, including 16 measures via a consent calendar. Measures can only be included on the consent calendar if they meet all consent calendar criteria including receiving an 80 percent or greater passing vote for overall suitability for endorsement by the respective E&M standing committee. Measures on the consent calendar are approved for endorsement via offline review, where CSAC members have the opportunity to review the measures and request to pull measures from the consent calendar for discussion and vote. For the Fall 2022 cycle, no measures were pulled for discussion, therefore all 16 measures on the consent calendar were endorsed during the July 24 CSAC meeting without discussion. The CSAC discussed and voted on the 12 remaining, non-consent calendar measures during the July 24 meeting.

The CSAC measure endorsement decisions are final. The 30-day Appeals period for endorsed measures is open from August 4 – September 3, 2023.
