

# **Consensus Standards Approval Committee Voting Results and Decisions for the Spring 2023 Measures**


The Consensus Standards Approval Committee (CSAC) convened for a web meeting on December 6, 2023, to review candidate measures for the Spring 2023 cycle. The tables below illustrate voting results for the following endorsement & maintenance (E&M) standing committees:

- Patient Safety
- Prevention and Population Health
- Primary Care and Chronic Illness

For the Spring 2023 cycle, the CSAC endorsed eight measures via a consent calendar. The CSAC also approved one electronic clinical quality measure (eCQM) for trial use. Measures were included on the consent calendar if they met all <u>consent calendar criteria</u> including receiving an 80 percent or greater passing vote for overall suitability for endorsement by the respective E&M standing committee. Measures on the consent calendar were approved for endorsement and trial use via a process of offline review, where CSAC members had the opportunity to review the measures and request to pull measures from the consent calendar for discussion and vote. For the Spring 2023 cycle, no measures were pulled for discussion, therefore eight measures on the consent calendar were endorsed and one eCQM was approved for trial use during the December 6 CSAC meeting without discussion.

The CSAC discussed and voted on the three remaining non-consent calendar measures during the December 6 meeting. Of these three measures, the CSAC endorsed one measure and did not endorse two measures.

The CSAC measure endorsement decisions are final. The 30-day Appeals period for endorsed measures only is open from December 11, 2023, to 11:59 PM EST on January 9, 2024.
